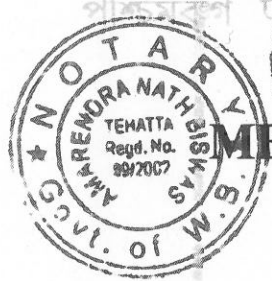

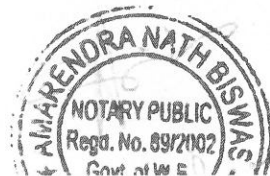

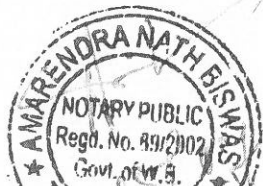
The institution intends to achieve its objectives by means of the followings:

III. PROGRAMME/ACTIVITIES TO BE UNDERTAKEN UNDER THIS MOU

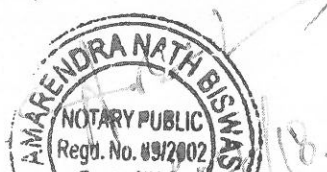
- Joint Organization of International/National/State Level Seminar/Workshop/Conference

2. Extension : The period of MoU signed may also be extended if found mutually beneficial.
3. Termination :
 - i. Any programme undertaken may be terminated after due evaluation and feedback, if found unproductive and untenable.
 - ii. The entire MoU can also be terminated anytime without being a burden for any party, of course, with a minimum of three months' notice from either side.

V. MEETINGS AND REPORTING

To accomplish these objectives, the partners will meet at least Two (2) Times a Year for the purposes of programme planning and monitoring and evaluating the outcomes. Decisions at the meeting will be decided by consensus and be reported to the authorities concerned duly.

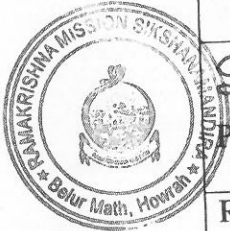

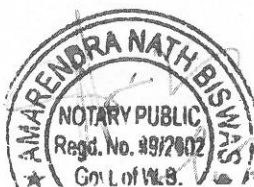
