II. BACKGROUND

- A. IV. IT IS MUTUALLY UNDERSTOOD AND AGREED UPON BY THE PARTIES THAT:

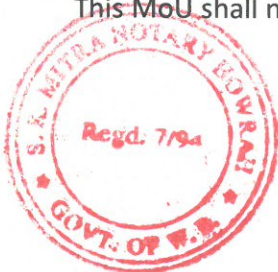
1. Modification : The programme undertaken shall be reviewed periodically and based on feedback received be modified, if required for optimal output and administrative and operational convenience.

 - ii. The entire MOU can also be terminated anytime without being a burden for any party , of course, with a minimum of three months' notice from either side.

To accomplish these objectives, the partners will meet at least **Two (2) Times a Year** for the purposes of programme planning and monitoring and evaluating the outcomes. Decisions at the meeting will be decided by consensus and be reported to the authorities concerned duly.

This MoU shall not include any kind of reimbursement of funds between the two parties.









VII. EFFECTIVE DATE AND SIGNATURE
