

8. FORCE MAJEURE:

Neither Ramakrishna Mission Sikshanamandira nor Nabadiganta Tapassya Foundation shal be held responsible for non-fulfillment of their respective obligations, under this agreement, due to the exigency of one or more of the force majeure events such as but not limited to acts of God. War, Flood, Earthquakes, Strikes, Lockouts, Epidemics Riots, Civil Commotions etc. provided, on the occurrence and cessation of any such event Ramakrishna Mission Sikshanamandira affected thereby, shall give a notice in writing to Nabadiganta Tapassya Foundation within one month of such occurrence or cessation. If the force majeure continues beyond six months, the parties shall jointly decide about the future course of action.

5. SCOPE OF MOU

This agreement details the terms & conditions of modalities of collaboration and responsibilities and obligations of Ramakrishna Mission Sikahanamandira and Saraksha Diagnostics pertaining to providing hands-on experience to the students in the public health and hygiene related service activities.

6. RESPONSIBILITY OF RKM SIKSHANAMANDIRA

RKM Sikshanamandira will engage its interested students in rotation, to attend the call and collect the necessary information from the person for camp registration / listing up. On the day of RT PCR Test / Vaccination, RKM Sikshanamandira will facilitate and provide all the camp conduction related support and ensure following up of the necessary COVID norms imposed by the Government. RKM Sikshanamandirs will provide subsidies in the RT PCR Test / Vaccine price to economically challenged persons. In this regard, upon receipt of the valid hill from Surakoha Diagnostics, RKM Sikshanamandira will electronically transfer the amount to the Bank account provided by Surakoha Diagnostice.

8. FORCE MAJEURE:

Neither RKM Sikshanamandira nor Suraksha Diagnostics shall be held responsible for non-falfillment of their respective obligations, under this agreement, due to the exigency of one or more of the force majeure events such as but not limited to acts of God. War, Flood, Earthquakes, Strikes, Lockeuts, Epidemics Riots, Civil Commotions etc. provided, on the occurrence and cessation of any such event RKM Sikshanamandira affected thereby, shall give a notice in writing to Suraksha Diagnostics within one month of such occurrence or cessation. 9. TERMINATION OF AGREEMENT
